Inclusion Planning – A Guide for Local Government

The sub-committee reported to the meeting that they have met several times to discuss and form recommendations after detailed consideration of the Australian Local Government Association's document 'Disability Inclusion Planning – A Guide for Local Government'.

The overall aim is the make the document a guiding, living document within Council.

Playgrounds in particular were discussed, and it is hoped that input into the draft strategy will result in improved inclusiveness for play facilities across the municipality.

It was agreed to invite Council's Urban Designer to attend the December meeting.

The sub-committee is to continue formulating an operational plan for improved inclusion and will work to create short, medium and long term goals to be recommended to Council for adherence to.

Committee Membership

In relation to committee membership the Access Advisory Committee's Terms of Reference state:

6. Membership

Members are appointed as an advisory committee to Council and shall comprise of the following:

(b) Organisational representation – up to five (5) organisations, with one representative from each, with an interest or involvement in matters relating to access. (c) Individual representation – up to eight (8), resident in the municipality if possible, and covering a broad range of disabilities or interest categories.

It has been recommended by Committee members that a variety of organisations and groups be approached in order to broaden membership on the Committee. It was also recommended that supported houses within the municipality be invited to put forward a nominee with the understanding that Baptcare's Community Connector staff provide individual support should it be required. Staff to follow up with letters to groups and individuals.

Kingston Park Community Hub

It was requested that a verbal update be provided to the Access Advisory Committee regarding developments at the Community Hub. Further to this it was requested that, in the event that 'experts' are engaged to undertake work and/or design which might impact on access, the Access Advisory Committee be provided with the opportunity to give input.

Reporting of Access Issues in the Community

It was mentioned that the app 'Snap, Send Solve' could be used for the wider public to report access difficulties. The group was informed that the app is currently used by some and reports are received at Council but the app is not the most effective means of communicating where problems exist.

It was reported that Council is currently creating a categorised method of reporting issues which is able to contain an "access" category which will provide clarity for those reporting an issue and for those receiving a comment.

GENERAL BUSINESS

Broader Network Group

Universal Access Forum

Collaboration with other Councils was initiated and has resulted in involvement with a proposal to host a southern Tasmania Universal Access Forum in 2018.

Kingborough area was offered as a possible location for the event however Clarence Council has decided to retain the event at the Blundstone Arena. Discussions are to continue with input from the Access Advisory Committee regarding forum content.

Accessible Events Guide

Suggestions and changes to the draft *Accessible Events Guide* were noted. Changes to be made and a revised draft document forwarded to the Committee for comment.

Guest Speakers List

It was suggested that a list of guest speakers be prepared in order to expand the reach of the committee and better inform those in the community who might benefit from the expertise of the group. Suggested speakers could include: Real Estate Agents, representatives from building companies and the Housing Industry Association. Staff to follow up.

All-Abilities Films

The group was informed of films which promote the possibilities for people of varied abilities.

'Lowest to Highest' and the 'Access All-Areas Film Festival'.
