QUESTIONS ON NOTICE FROM THE PUBLIC

C176/6-18

(Commences at ± 2 minutes of audio recording)

North Roslyn Avenue Traffic Safety

At the Council meeting on 13 March 2018, **Ms Tricia Ramsay** asked the following question without notice to the General Manager, with a response that the question would be taken on notice:

1. Council was planning to duplicate last year's winter traffic counting on North Roslyn Avenue is counterproductive. In August last year we requested that vehicle counting occur this summer to reflect the additional seasonal traffic associated with tourism, recreation and construction as well as heightened social activities. It was a rational legitimate ratepayer request. Why was it not acted upon?

- 2. Why hasn't the work been done that Council promised would be completed in mid-February this year?
- 3. Why hasn't anything tangible been done to alleviate the excessive traffic speeds in last winter's traffic counting? Then, it was described by your officer as very concerning with almost consistently hourly maximums between 80 and 90kms/h. And other instances where vehicle speeds exceed 100km/h, the highest being 107?
- 4. The planned area traffic survey will be compromised if it omits data from Jindabyne Road and Kingston Heights. In the absence of a Kingston traffic plan, will Council ensure that data from these two relevant areas be included in the forthcoming traffic survey?

Officer's Response:

- Traffic counts are not generally accurate during summer time as this takes in the majority
 of the Christmas school holiday period. Council committed to the undertaking of a larger
 local area traffic survey to try to understand the origin and destination of the large majority
 of traffic which travels along the northern section of Roslyn Avenue. The survey needs to
 reflect typical daily traffic movements, not seasonal peaks.
- 2. Works to replace missing guideposts and install signage is being programmed.
- 3. Work is being programmed for improved speed limit delineation.
- 4. The North Roslyn Avenue area traffic survey is proposed to capture Auburn Road, the Kunama Drive area, Jindabyne Road and the Kingston Heights area.

3 State of Council Roads on Bruny Island

Mr Mervin Reid asked the following question without notice:

"Recently I had the pleasure of a weekend on Bruny Island and drove right around both North and South Bruny Island and I was quite concerned that the state of the roads, particularly the lack of apparent grading and in some cases, re-sheeting of the Council maintained roads. Specifically, the road from Lunawanna to the State controlled road at the boundary of the light house on South Bruny was not very good with substantial potholes for a lot of the road and on some parts of the road it was apparent that grading had not been done for some time. There is a sign saying that this road is maintained by Council. The roads on North Bruny were not much different particularly the road leading to Dennes Point. It appears that the grader that was disclosed to be resident on bruny Island has not been all that active and therefore my question is:

- 1. When can the Bruny Island residents expect that the grading of the roads will be brought up to standard given the traffic on them?
- 2. How long will it be before they can see some action, especially given that Council has a grader stationed on the island?"

General Manager responds:

We have previously answered this question, at least in part, in relation to the use of both graders that Council has under its ownership but we will take that question on notice and provide a written response.

1 Building Permits over Crown Land

Cr Grace asked the following question without notice:

"We have roads in our municipality that Council don't maintain. My first question is, why do we issue a DA and a building permit for people which we have no control over that road to their boundaries? When we are asked a question we are told it is Crown road reservation. How do these people get a permit to build when we have no authority over the Crown land?"

General Manager responds:

One example that readily springs to mind is the private road that everyone, myself included as a resident of Kingborough, uses to access the Blackmans Bay Shopping Centre. It's a private road. Historically when the permit was issued for the subdivision and subsequent developments, the ownership of the road remained in private and there is a sign that the Council have erected there that it is a private road. The other part of your question that relates to access is one where the proponent of any DA application is required, if they don't have legal access with their own title, to make an application that records that they make the application with the consent of the land owner which, in that occasion, would be the Crown.

Cr Grace:

I understand that but in this case they weren't asked to do that.

General Manager responds:

I would need to know the specific details, Cr Grace, to be able to answer the question.

Cr Grace:

I can furnish you with more details when we meet tomorrow.

2 Findings of the Tasmanian Audit Office

Cr Bury asked the following question without notice:

"Could the General Manager please confirm or deny the understanding of the findings of the Tasmanian Audit Office regarding Kingborough Council, that:

- 1. We have the lowest rates per rateable property.
- 2. We have the lowest rates per capita.
- 3. We have the lowest operating costs per rateable property.
- 4. We have the lowest number of full time equivalents per head of population.
- 5. We have the second lowest staff costs per FTE this is amongst the five largest Councils.
- 6. In the last Census figures which data is available, Kingborough Council is second only to Hobart out of 29 Councils in the list of socio-economic advantage."

General Manager responds:

Your question and statement is accurate. The Auditor General is on the public record as saying that in the grouping of the five largest Councils, the Council that we represent, Kingborough Council, does in fact have all of the above as you have outlined.

"Following on from that question, I think Cr Bury may have mentioned that Council had a revenue problem according to the Auditor General. Where has the Auditor General set out of the officers belief that Council has a revenue problem? In what report?"

I don't have that information with me tonight but I will take the question on notice and will provide the answer in writing.

3 Aussie Waste Management

Cr Winter asked the following question without notice :

"At the last Council meeting we were advised that Aussie Waste had only one operational truck and would be sourcing two additional trucks, under a best case scenario, by the 15th March. Have these trucks arrived and, if so, when did they arrive and has Council inspected these vehicles and does Council believe that they are of a standard to complete the contract?"

General Manager responds:

I spoke with my colleague, David Reeve, about this very matter this morning. The trucks have arrived in the State. Aussie Waste have been able to access an additional two trucks. I'm not aware whether a Council officer has inspected them per se but Aussie Waste continues to work with Council officers to continue to provide the service that they are contractually required to do. That has been assisted on and off by another contractor, namely Veolia, in recent times.

Cr Winter:

Can you confirm that those two additional vehicles are now in use to perform the contract?

General Manager:

I asked the very question myself of my colleague this morning and the answer was that Aussie Waste had advised him that they had two trucks operational last week and he was seeking to confirm that that was the case today because the situation has fluctuated.

Cr Winter:

I understand that four trucks were damaged in the arson attack recently. Is Council aware whether Aussie Waste is procuring an additional two trucks so that they will have the same amount as they had before the fire?

General Manager:

My understanding, again, from my conversation this morning with Mr Reeve was that Aussie Waste continue to do everything within their capability to get their fleet back to where it was before the arson attack.

Cr Winter:

In terms of the contract and the completion of the contract, is Council confident that Aussie Waste is going to be able to deliver and complete the contract under its current terms and conditions?

General Manager:

Council officers continue to work with Aussie Waste to ensure the contract requirements are met.

Cr Grace:

Just following that, I believe that under the present Tasmanian law, trucks have to be passed by the Transport Authority before they can be, particularly mainland trucks brought back to the State, they have to go over a pit before they can be put on the roads here. I'm assured that Aussie Waste would be doing all of that correctly. I don't think they would be putting trucks on the road unregistered.

General Manager:

Cr Grace is correct and of the two trucks that were part of the question that Cr Winter asked, one was sourced from interstate and one was sourced from Tasmania, so one was already on the island.
