CHAIRMAN'S REPORT FOR 2019 AGM OF THE KINGBOROUGH COMMUNITY CONSULTATIVE FORUM

The Forum has, during the past year, continued to provide a useful and valuable communication conduit between community organisations and Council.

Many issues of concern to local communities have been brought to the attention of Council, although in some cases there have been long-standing matters which can be complex and/or very difficult to resolve to the respective community's satisfaction.

Nevetheless, I believe worthwhile progress has been made regarding many matters.

Our municipality continues to grow at a significant pace – possibly the fastest in the State. But this growth comes with many challenges for our area and its inhabitants, especially in relation to the provision of adequate infrastructure and services.

Kingborough is indeed a most appealing area in which to live, for the whole spectrum of its population from young people (singles and families) through to the elderly. However, for the many who need to travel regularly to Hobart, traffic issues are becoming increasingly frustrating. The added traffic from the rapidly growing housing estates on the outskirts of Kingston, as well as from Margate and beyond, make this a major issue for State and Local Governments to deal with. And the, as-yet, unclear nature and impact of proposed significant further development of Huntingfield will inevitably exacerbate the issue.

Council reports to Forum meetings provided by G.M. Gary Arnold and D.G.M. Tony Ferrier have again informed us on a whole range of matters; some of these, such as Kingston Park and the Planning Scheme, have been the subject of regular updates. The completion of a major portion of the roads and services infrastructure and the Community Hub and new Health Centre on the Kingston Park site is very pleasing, with future stages of development in the offing. It is expected that Council will soon be releasing its draft Local Provisions Schedule, which ultimately will become part of a new Kingborough Planning Scheme.

The attendance of Councillors, including some newly-elected last year, at some Forum meetings is appreciated and their contributions valued.

In conclusion, I wish to express on your behalf our appreciation to Tony Ferrier for his continued support of the Forum by way of Notices, Agendas and Minutes of our meetings.
