Caravan Habitation Application Form

Health and Environmental
Services By-Law 2021 (Part 7)

IMPORTANT INFORMATION FOR APPLICANTS:

This application must be completed by the owner of the land on which the caravan is to be occupied.

In accordance with Council's *Health and Environmental Services By-Law 2021 (the By-Law)*, a permit is required to occupy any caravan for more than 30 days (cumulative) in a calendar year. Permits are not intended to allow long-term, or ongoing occupation of caravans. Rather, in accordance with Clause 29(e) of the By-Law, a caravan permit may only be issued by Council under the following circumstances:

1. A permit to occupy a caravan may be issued for up to one year allowing a person(s) to occupy a caravan whilst building an approved primary place of residence, provided the following additional requirements are met:

- The property where the caravan is setup to be occupied is zoned Rural Living, Environmental Living or Rural Resource; and
- The caravan is either not visible from nearby roads or other residences or the caravan can be effectively screened to minimise impacts on residential amenity; and
- Planning, Building and Plumbing Permits have been issued for the construction of a primary place of residence; and
- An onsite wastewater management system has been approved by Council and installed to treat greywater and blackwater discharges from the caravan. (NOTE: other methods of blackwater disposal may be approved – eg. portable toilets, composting toilets, chemical toilets, but a suitable greywater treatment system must also be installed); and
- The caravan is not attached to any structure that is fixed to the ground – eg. decks, carports, etc; and
- Occupancy of the caravan at the site will not result in any increased impact on vegetation as a result of bushfire hazard management.

Or

2. A permit to occupy a caravan may be issued for short periods (up to six months) allowing a person(s) to occupy a caravan for emergency accommodation, provided the following additional requirements are met:

- The occupant(s) of the caravan have a genuine reason for requiring emergency accommodation in a caravan – eg. due to housing unavailability, bushfire, flooding, temporary unemployment, etc.
- The property where the caravan is setup to be occupied must have an existing approved primary place of residence; and
- The primary place of residence is connected to a reticulated sewerage system, or has an onsite wastewater management system suitably sized to manage any additional wastewater from occupants of the caravan; and
- The caravan does not contain an annex.



A site plan must be included below (or attached with the application). The site plan must clearly show the proposed location of the caravan on the site with relation to the property boundaries, access to water supply, location of any onsite wastewater system infrastructure, and any proposed screening.

NOTE: If the caravan is to be occupied in a rural area, the caravan must be located on the site such that it fits within the approved bushfire hazard management area, and will not result in any requirement for additional clearing of vegetation for bushfire hazard management.

- I have completed any and all information required on this application; and
- I declare that all information on this application is true, accurate and complete; and
- I have read the important information for applicants on the first page of this form; and
- I acknowledge this application is not valid and assessment of the application will not commence until all application fees are paid in full; and
- I acknowledge that relevant approvals under pertinent legislation that are required for the lawful occupation of the caravan and any use or development of premises has been obtained and complied with including, but without limitations, any and all approvals under the *Land Use Planning and Approvals Act 1993*, the *Building Act 2016*; and
- I acknowledge and agree that if an email address is provided on this application I consent pursuant to Section 6 of the *Electronic Transactions Act 2000* to the Council using that email address as a method of contact and for the provision of information by the Council; and
- I understand and agree that information on this form, and about the occupation of the caravan may be shared between Council Officers; and
- I understand that non-compliance with the provisions of the By-Law or the Permit to Occupy a Caravan may result in the permit being revoked and/or penalties being applied; and
- I understand Council may revoke the permit at any time if the conditions of the permit are not being met.
