10 QUESTIONS ON NOTICE FROM THE PUBLIC

10.1 Track at the Twin Ovals

Mr David Griggs submitted the following question on notice:

This track is totally unusable with any rainfall. It becomes a sloppy gravel mess, with rain and water draining off the bank above it. People with prams, wheelchairs, walking sticks, with older people and people of all ages falling. The surface urgently needs a bitumen surface, with proper drainage on top side of the track. There is a lack of a number of safe access from the track to the seating above. I realise this has a funding issue but it is a major public safety issue for council.

Officer's Response:

It is acknowledged that it would be desirable if the access path around the western side of the AFL Ground at the Twin Ovals was finished in concrete or bitumen rather than gravel. This matter has

been the subject of previous budget submissions and can be listed again for consideration in the 2024/25 capital works budget.

11 QUESTIONS WITHOUT NOTICE FROM COUNCILLORS

Cr Midgley asked the following questions without notice:

11.1 Art Work in the CBD

I've had a few community members ask me if there are going to be any urban art walls or murals to occur as part of the Transform Kingston project?

Director Governance, Recreation & Property Services responds:

We have a grant application in at the moment and that's to do a mural under the underpass. There are no proposals for murals in the main street.

Cr Midgley:

What is the process for including public art in our major projects?

Director Governance, Recreation & Property Services:

We don't have a defined process in relation to that. It generally comes through the planning and the scoping for a project and the community consultation that forms part of that scoping process as to whether there is interest or suitability for inclusion.

Cr Midgley:

So we don't really have a procurement or EOI process as part of our planning to include public art?

Mayor:

No, that's correct.

11.2 Councillor Engagement Projects for Possible Inclusion on Committee Agendas

I attended the Kingborough Community Forum and I asked if we could include the current engagement processes, the sport and rec survey and the wellbeing survey that were out at the moment because I noted that they weren't on the agenda. I had a thought generally for committees and the forum, if the forum agreed to it, that there could be a reoccuring agenda item that included current Council engagement projects?

Mayor responds:

Certainly that is something that we can take on board. I think one of the issues might be timing with some of those surveys. For example, it was only late last week that we put out the multicultural survey, so by the time the next agenda comes around for the community forum, that period would have closed because our surveys are generally open for about 4 weeks. Certainly it is something that we could raise with staff so that there is an automatic email that goes out to the members of the forum so that they are all aware.

Cr Cordover asked the following question without notice:

11.3 Headworks Charges Policy Framework

When a development is proposed that requires the installation of new infrastructure or the upgrade of existing infrastructure, what proportion of the cost is passed on to the developer and what proportion is born by the Kingborough ratepayer and what's the relevant policy framework that guides those decision?

Director Engineering Services responds:

We don't have a formalised Headworks Policy and it has been one that has been talked about for a while. We assess every development on it's own merits and if a developer is making a direct impact associated with an asset, the requirement is on the developer to upgrade whatever that asset happens to be, to allow that development to proceed. The difficulty that comes into play is when you are putting in new developments and there are incremental effects on networks, that's where headworks comes into play, and that's where we don't have a policy or framework currently to allow us to deal with that.

Cr Cordover:

At what stage is the development of a Headworks Charges Policy at and when should we expect to see either a workshop or maybe a report to Council about that issue?

General Manager responds:

The Local Government Association of Tasmania on behalf of the local government sector across the State are currently undertaking investigations into headworks. It has been a matter that has been discussed at general meetings of LGAT since 2018/19 and that work is currently in process.

Cr Cordover:

Is Kingborough very different from other municipalities with respect to any kind of implementation of headworks charges? Will it be a bespoke approach for Kingborough or do we think that whatever LGAT comes up with won't actually need that much massaging for it to be implemented in Kingborough?

Mayor:

I don't have a crystal ball so I can't tell you yet what they might come up with and whether it would be appropriate.

Cr Deane asked the following question without notice:

11.4 Taroona Toilet Block

Could we get a progress update on the works happening at the toilet block?

Mayor responds:

Work has started and we are hoping that it will be completed by November ready for the summer season.

12.1 Signage at the Hub

At the Council meeting held on 4 September 2023, **Cr Cordover** asked the following question without notice to the General Manager, with a response that the question would be taken on notice:

What is our current policy regarding the playing of sports with a ball in the Kingborough Community Hub? The reason for my question is that somebody mentioned to me that it's now forbidden or there is some signage around it and I want to understand what that signage is and are we directing people, through that signage, to a more appropriate area to chuck the ball around or is it completely forbidden throughout the whole area?

Officer's Response:

There are restrictions on certain activities around the Hub building, such as roller-skating, skating, scootering and ball games. Restrictions were introduced in response to the impacts that the noise generated from those activities were having on the indoor spaces that are hired by people/groups. There are alternative areas for those activities such as the basketball area beyond the flying fox and the large open space areas on the lower part of the recreation area. There is signage in place around the Hub outlining that limitation.
